SECTION 4

FIRST AID MEASURES

4.1. DESCRIPTION OF FIRST AID MEASURES

INHALATION

Aryl thiophosphate: Effects on the liver, adrenals, thyroid, blood and reproductive organs were seen in rats after repeated oral gavage at high doses. In a reproduction/developmental toxicity screening study, repeated oral gavage of rats with the aryl thiophosphate at high doses that produced maternal toxicity resulted in litter loss, decreased number of implantation sites and decreased number of live pups.
